1. RULES OF THE ALPINE FIS POINTS

Only one result in between periods

4.2.2.4 Only one Result and BL points

If the competitor has only 1 result per event during the current period, but has BL points, then the BL points will be valid.

2. INTERNATIONAL SKI COMPETITION RULES (ICR)

Duties of the Referee

601.4.10 Duties and rights of the Referee

- The Referee supervises the draw.
- ~~- Inspects the course immediately after it is set, alone or accompanied by members of the Jury.~~
- ~~- The Referee has the right to change the course, by removing, changing the course by taking out or adding gates. If the Referee inspects the course alone his decision is final. The course setter must be informed of such changes if he was not present at this inspection.~~
- At the end of the first run, and again at the end of the race, the Referee will receive the Start and Finish Referees' reports, and any other official reports regarding breach of rules and disqualifications.
- Checks, signs and posts the Referee's Report on the official notice board at the end of each run, and at the end of the race, including a list of disqualified competitors, the gate numbers where the faults occurred, the name of the relevant gate judge or judges, and the exact time of the posting.
- Sends a report to the FIS should unusual circumstances arise or in the event of a difference of opinion among the Jury members or in the case of severe injury to a competitor.

Yellow Flag

623.1.3 ~~When a competitor is waved down by a yellow flag he must stop immediately. If a competitor is stopped by a yellow flag,~~ He has the right to a re-run, provided that the Jury considers this possible from an organisational point of view. The Jury should ensure that the competitor's re-run takes place before the last competitor on the start list of the race, or training run in the case of Downhill (see 705.2, 705.3).

3. WORLD CUP

World Cup Rules

18.4.1 Termination and classification of a competition

The jury is authorized to terminate a competition and to decide, if the race is to be classified.

A competition can be terminated, if the competitors are endangered by external disturbing influences, if conditions are irregular or the proper running of the race is no longer guaranteed (for example through fog, wind gusts, rain, etc.) and a completion of the race on the same day under regular conditions can no longer be expected. There is no right of appeal under art. 647 of the ICR in regard to termination.

18.5.1 A competition that only consists of one run can be classified if at least the best 30 on the start list have started.

4.6.3 Team Hospitality

The Organising Committee is required to provide appropriate team hospitality at the competition site(s) for the athletes, coaches and service personnel. The team hospitality area should be large enough to enable these team members to prepare and/or relax in a secure, comfortable environment. The area should be equipped with adequate seating, heating, and provide healthy warm and cold food and beverages and proper washroom facilities. Furthermore heated and separate waiting room(s) have to be put at the disposal of the competitors near the start area(s) in which the competitors can stay during trainings, respectively between the two runs or heats of a competition.

4.9 Internet access

Athletes, team members and servicemen are entitled to free of charge Wi-Fi access within the Team hospitality or the Team area in the Finish area and in the Team hotels or other area(s) designated by the Organiser wherever feasible. Any costs for this access are the responsibility of the Organiser. The Organiser should also provide free of charge Wi-Fi access to the media in the Finish area.

4. INTERCONTINENTAL CUP

Increase the Basis quota in Speed Events

2.1. Basic Quota

Each nation is entitled to a basic quota of two (2), three (3) in DH event, on condition that these competitors have a maximum of 120 FIS points (SAC, ANC 140 FIS points in SL or GS, 160 FIS points in SG, DH or SC) on the valid FIS points list, as follows:

- Slalom and Giant Slalom: in any of the five events
- Downhill and Super Combined (with DH): in Downhill or Super-G
- Super-G and Super Combined (with SG): in Downhill, Super-G or Giant Slalom

Validity of the Basic List

3.1.4 *Validity of the Basic List*

After the second (~~EC~~, FEC, SAC, ANC), third (NAC in GS and SL events) race in that event in the current season the basic list will be deleted. In NAC for DH, SG and SC only two events will be used before the basic list will be deleted. Only the Cup points gained in the current season count. In EC the Basic List will be deleted after the third race in all events.

Maximum number of starts for U18 (1st Year)

607.3 Classification at International Competitions

1) 1st year U18 (Junior I): maximum number of starts per season in Giant Slalom and Slalom events counting for FIS points = 25. Any results from races after the maximum of 25 starts for the first year U18 (Junior I) athletes are cancelled and therefore do not count for FIS points. ~~(Not valid for the season 2012/13).~~ There is no limit to participation in the speed events Downhill, Super-G and Super Combined.

The Sub-Committee for Classification will inform the FIS Council of any infringements of the rule.

Distance Slalom course setting

801.2.3 A gate must have a minimum width of 4 m and a maximum of 6 m.

The distance from turning pole to turning pole of successive gates must not be less than 6.00 m and not more than 13 m (valid for all categories). Exception Children's competitions:

- ~~U16 (K2) between 7 m and 11 m, not more than 12 m.~~
- ~~U14 (K1) not more than 10 m~~

The distance between gates within combinations (hairpin or vertical) must be not less than 0.75 m and not more than 1.00 m. The gates in hairpin or vertical combinations must be set in a straight line. Delayed gates must have a minimum distance of 12 m and a maximum distance of 18 m (Children's Competition 15 m) from turning pole to turning pole.
