- 2002 2.3 **Minutes of Previous Meeting**
The minutes of the previous meeting 2002.1 were approved as a true record.
- 2002 2.4 **Matters Arising**

- 2002 2.5 **Report From ARC**
- 2.5.a AW advised that a number of items from the last ARC meeting held on Saturday 20th April will be covered later in the agenda
- 2.5.b AW advised that a general discussion took place over the accountability and decision making of the various ARC Sub Committees. It was concluded that ROTP will need to circulate to ARC, prior to each of their meetings the forthcoming agenda together with relevant background notes and any items that need to be ratified. This is with a view to speeding up the decision making process.
- 2002- 2.6 **Alpine Race Series**
- 2.6.a The document that was provided by Derek Metters was discussed. All agreed that Derek should be congratulated on the in depth nature of the report. It was further agreed that AW should write to Derek on behalf of ROTP passing on our sincere congratulations to both him and all his team for an excellent championships.
- 2.6.b GHC gave a brief update of the current position of the 2003 championships. Advising that he had put together a small team consisting of AW, Derek Metters, Richard Berry and GHC with a view to look at the feasibility of the Junior/Senior part of the championships becoming a FIS event.
- 2002 2.7 **Race Officials Training**
- 2.7a CMO gave a detailed report on the meeting of the Race Officials Training Sub Committee that was held on the 21st April 2002. (see attached).
- 2.7b AW asked CMO to pass on our thanks to the Sub Committee for all their efforts and requested that they meet again as soon as possible to put together the finite detail of the proposed courses.
- 2.7c Possible dates for the annual level 2 course is November 23rd and 24th. With the level 1 courses planned for Sandown Park on the 22nd September, Pendle late July and Silksworth sometime in August.

- 2002 2.8 **Accreditation Scheme**
2.8a It was agreed that level 1 accreditation could be approved by any member of ROTP or any TD.
Level 2 accreditation must be by a TD.
